**Key points from the May 1<sup>st</sup> Executive Meeting:**

✓ **The Draw**

The Executive reflected on the process of making this season's fixture, and decided we need:

- i. An end of season meeting with clubs to reflect on what went well, and what can be improved.

- ii. A meeting early in the year to discuss the draw, which could be held in conjunction with the AGM.
- iii. An earlier date by which clubs need to enter their teams.

✓ **Finals**

- i. There will be finals for the under 13 Sixers, but how this will be structured will be reviewed at the next Executive Meeting.
- ii. The first round of A Grade finals will be held at Echuca; all other finals will be held in Shepparton.
- iii. The Senior Grand Finals will be held on Saturday, September 9<sup>th</sup>.

✓ **The Child Safe Standards**

The Child Safe Standards are the compulsory minimum standards for organisations that provide services for children; they are set out by the Victorian Government and are designed to help protect children from abuse. In accordance with these Standards, the GVHA will be adopting a Child Safe Policy. Further information about this will be sent to all clubs in the near future.

✓ **The 'Reciprocal Umpiring Rule'**

- i. For senior games, when there are two games being played on the same day, the teams playing second must supply umpires for the first game, and the teams that played first will then umpire the second game.
- ii. To avoid any confusion, the GVHA Secretary will send out a copy of the fixture which includes the names of the clubs who need to supply umpires for each game. This will be sent out to all clubs very soon.

✓ **RHL Umpiring**

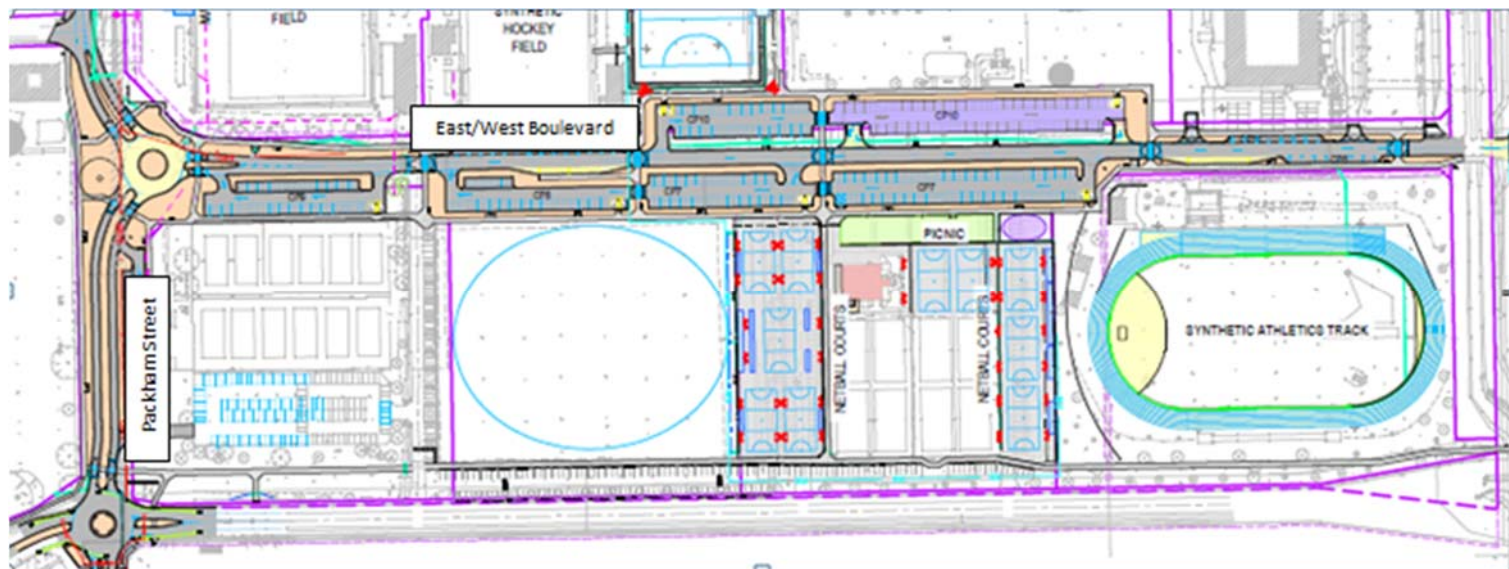
- i. Hockey Central Victoria supplies the umpires for games played in Bendigo.
- ii. GVHA is required to supply umpires for the RHL games played in Shepparton, and this must be organised by the clubs. When there is more than one RHL game being played, the Reciprocal Umpiring Rule applies.

**A message from Greater Shepparton City Council:**

Council wishes to notify all users of the Sports Precinct that the East/West Boulevard roadway and car parking have been sealed and are ready for use. There are over 600 car

paths between the netball, hockey and soccer facilities, with connecting footpaths and designated pedestrian crossings.

To access the car parking facilities please use the Brauman/Packham Street roundabout and then turn right at the internal roundabout. Please remember to obey all road signs including the “No standing areas” at the front of the netball courts along Brauman Street. This area cannot legally accommodate parallel parking.
